Mayor Penland called the July 6, 2015 meeting of the Chatsworth City Council to order. He presented the minutes of the last meeting and the agenda for this meeting.

Request the reappointment of Milton Clarke to the Chatsworth water commission (Six year term to expire July 2021)

Gary, "I make a motion we accept this. Milton has been on the Commission for twelve years."

Brad seconded and the motion passed by a vote of 3 to 0.

Request the reappointment of Betty Hampton to the Chatsworth Murray County Library Board for a three year term to begin July 1, 2015 and expire July 31, 2018.

Brad, "I will make a motion we appoint her." Gary seconded and the motion passed by a vote of 3 to 0.

Request the approval of a malt beverage license for Timakiben Patel, Hi-Tech Express, 1317 Highway 76, Chatsworth, Georgia.

Fred, "I make a motion we accept." Gary seconded and the motion passed by a vote of 3 to 0.

Request the approval of a malt beverage license, wine license, and liquor license for Erendira Villeda Ramirez dba Fiesta Mexicana #12, 1422 Green Road, Suite T, Chatsworth, Georgia.

Fred, "I make a motion on that one as well." Brad seconded and the motion passed by a vote of 3 to 0.

COMMITTEE REPORTS

FINANCE: I have reviewed the income and expense reports for the month and expenses are just a tad over income. It is really prepaids earlier in the year. It is in balance and good. We are in the process of getting the budgets submitted, collated for the council's review.

INFRASTRUCTURE: The Duvall Road project is completed. The solar project is completed and started producing last Wednesday, July 1, 2015. Solar power will supply power for the wastewater plant and the office.

INTERGOVERNMENTAL & TECHNOLOGY: Ms. Martin is on vacation this week.

PUBLIC SAFETY: Mr. Welch advised the police and fire reports were ready for review.

Assistant Fire Chief Parker advised that the reports were new and they were still getting used to the New World software. The new truck had to be sent off for repairs. It should be back in the next week or two. The old radio tower has been removed. We also received a vehicle fire located inside the Georgia Carpet Finishers on Lowy Drive. While extinguishing that fire one of the firefighters received first and second degree burns on his lower extremities.

We responded to thirteen EMS calls during the month of June. On the 29th we were dispatched to North Fifth Avenue to a report of a female patient unconscious, not breathing and no pulse. We were also advised that CPR was in progress. When we arrived we noticed Glen Yother, a street department employee, was doing the CPR on the patient. He continued the CPR until firefighters could place an AED on the patient. As of Thursday, she was responsive and following commands. There is no doubt without Mr. Yother's CPR there would certainly have been a much worse outcome on the call.

I feel Mr. Yother's actions should be commended for going above and beyond his current employment with the City of Chatsworth.

Chief Etheridge advised it had been another busy month. There are changes with the reports as we go onto the New World System. I still want to bring your attention to the continued increase in drug cases.
