The Chatsworth City Council met in regular session on Monday, October 3, 2016 at 6:00 p.m. in the council chambers of City Hall with Mayor Tyson Haynes presiding.

COMMITTEE REPORTS

FINANCE. Finance Chairman Rowe advised that September expenditures were \$305,000 and revenues were \$158,000 leaving us with a deficit for the month. We have money coming in October. With this going into the general fund it will put us in a positive position.

ECONOMIC DEVELOPEMNT AND TOURISM: Ms. Martin did not have anything to add at this time.

PUBLIC SAFETY: Chief Etheridge advised thät it was a pretty normal month with the exception of animal complaints. They received 35 animal complaints in September. He came asking for some guidance from the council on the manner they wish the animal complaints handled. The council will review the current service agreement and seek to find a more workable solution.

Chief Baxter advised there were several accidents and other calls this month.

PUBLIC SAFETY. The street department has been backfilling on Second Avenue to raise the shoulders. Paving will continue on South Second Avenue and City Hall. The sidewalks will be poured in front of the courthouse.

Mayor Hayneé advised that any work that was done on the streetscape project will be handled with Federal O.S.S.P. funding.

Mayor Haynes adjourned the meeting at 6:35 p.m.
