COUNCIL MEETING
FEBRUARY 6, 2017**

The Chatsworth City Council met in regular session on Monday, February 6, 2017 at 6:00 p.m. in the Council Chambers of City Hall with Mayor Tyson Haynes presiding.

PRESENT: Mayor Tyson Haynes, Aldermen: Celeste Martin, Jeff Cloer and Fred Welch. City Attorney Steve Williams.

Mayor Haynes called the meeting to order and presented the minutes of last meeting and the agenda for the current meeting for review and approval.

Presentation of the second reading of an amendment to the soil and erosion ordinance.

COMMITTEE REPORTS

FINANCE: Finance Chairman Walsh advised that the department heads were able to hold the budget in the black for 2016.

INFRASTRUCTURE: Everett advised they had disposed of 20 loads of debris at a cost of \$1290.00. They also disposed of 62 loads of brush and 10 loads of leaves. The sanitation department disposed of 20 loads/106 tons.

They also will be purchasing a hydraulic jack and a demolition saw.

INTERGOVERNMENTAL & TECHNOLOGY: Dolley advised they would be filing the MS# report on 02-15-17.

Steve Smith advised they are still operating under Level 2 drought restrictions.

PUBLIC SAFETY: Chief Etheridge advised they had responded to 1541 calls. These include personal offenses, theft, speeding, etc. They are dealing with increased numbers of subjects with diminished mental capacity.

Assistant Chief Parker advised the fire department has responded to 60 calls, 22 of these were medical. They also had 322 hours of training.

Assistant Chief Parker advised the statewide GEMA testing would be held on Thursday, weather permitting.
