The Chatsworth City Council met in regular session on Monday, July 7, 2014 at 6:00 p.m. in the Council Chambers of City Hall with Mayor Dan Penland presiding.

**PRESENT:** Mayor Dan Penland, Aldermen: Brad Rowe, Celeste Martin, Gary Brock and Fred Welch. Attorney Steve Williams and City Clerk Wilma Nolan.

Mayor Penland presented the minutes of the last meeting and the agenda of the July meeting for review and adoption.

**COMMITTEE REPORTS**

**FINANCE:** Year to date we are at 59% which include capital purchases and staff additions. On the income side we are at 32% but tax collection comes at the end of the year. But all in all departments are at budget or just under at this point.

**INFRASTRUCTURE:** Everett's reports were presented for review. The rain has created tile issues and we are behind on the mowing.

The water commission is running normal.

**INTERGOVERNMENTAL AND TECHNOLOGY:** Ms. Flood advised they are proceeding as normal.

**PUBLIC SAFETY:** Mr. Welch advised that the reports are ready for both departments. Chief Baxter advised they had sent two guys to the Guardian Center in Perry, Georgia for training.

Chief Etheridge advised the fireworks were well attended. They responded to over 1200 calls last month. Personnel changes have taken place with Michael Parker assigned to investigator, Brian Ingle was promoted to sergeant and Officer Sosebee was assigned to canine.

H.B. 60 was discussed and Chief Etheridge inquired if the council wanted an officer posted outside the building to verify no one enters with a firearm. Discussion followed and it was agreed to post signage and post an officer for council meetings.

Irko and drug investigations have resulted in the city seizing several thousand dollars.
