


Mayor Haynes called the final public hearing of the proposed tax increase to order.

Mayor Haynes presented the five year tax levy history and the proposed millage rate of 3.00 mills the same as 2018 along with other information.



SEPTEMBER 9, 2019

The Chatsworth City Council met in regular session on Monday, September 9, 2019 at 6:00 p.m. in the council chambers of city hall with Mayor Tyson Haynes presiding.

PRESENT: Mayor Tyson Haynes, Aldermen: Rhett Griffin, Jeff Cloer and Fred Welch. Consultant K. W. Gong. City Clerk Wilma Nolan.

Mayor Haynes presented the minutes of the last meeting and the agenda for the current meeting.

Following review, Fred, "I make a motion we approve the minutes and agenda as presented." Rhett seconded and the motion passed by a vote of 3 to 0.

OLD BUSINESS

NEW BUSINESS

Presentation of the MS-4 report by Dolley Flood.

Dolley advised the 2018 Annual Report was filed February 2018. On June 26, 2019, we met with our new EPD Representative, Mildred Granderson to review our 2018 annual report. The purpose of this inspection/audit of our stormwater management program was to evaluate the implementation and administration of the program. During the evaluation, Mildred reviewed our records and gave recommendation on the administration of our documentation. Also, during her visit she oversaw the dry weather inspection on the section of the town branch located beside the city street department which was successful.

The city received notification on July 30, 2019 from Mildred stating how our SWMP/Annual Report program was being implemented, along with revisions to the annual report. At this time the city is taking steps towards implementing those revisions and improving documentation. Overall she seemed pleased with the annual report. The EPD has requested revisions and better documentation to the 2018 Annual Report and currently, all departments are implementing those required revisions. However, we were unable to meet the requested August 30th deadline and Steve Smith has requested a ninety day extension from the EPD.

The Water Works Commission has recently hired Jonathan Wells as the new Stormwater/GIS Coordinator. He will implement the program in place of Hayden Hooper, who has taken a new position.

1. I have begun our Municipal Facilities inspections and the privately owned pond inspections. Those inspections will continue through the end of September and ending in October. Documentation of these inspections will be revised and implemented in our 2019 annual report.
2. We will continue to make improvements and updates to our web site as well as our compliant response reporting.
3. We will be conducting our annual Stormwater training with the County Departments and the City of Eton will be added this year.
4. Mapping and Outfall will be reported separately in our 2019 annual report and updates to the inventory are being implemented.
5. We will revise the IDDE plan to include the mapping inventory totals.

We will continue to make better strives to implement our Stormwater program as needed. It is a team effort and I feel as if we have a great team and will be successful.

Presentation of a proposed Soil and Erosion Amendment - Following presentation, Fred, "I make a motion this be approved as the first reading." Jeff seconded and the motion passed by a vote of 3 to 0.

Presentation of an intergovernmental agreement on TSPLOST for adoption. The agreement reads as follows:

INTERGOVERNMENTAL AGREEMENT

WHEREAS, Murray County, Georgia (Hereinafter "the County"), is a political subdivision of the State of Georgia:

WHEREAS, The City of Chatsworth a municipal corporation located within the geographical boundaries of Murray County, Georgia, and is organized and chartered under the laws of the State of Georgia.

WHEREAS, the City of Eton is a municipal corporation located within the geographical boundaries of Murray County, Georgia, and is organized and chartered under the laws of the State of Georgia.

WHEREAS, the Commission of Murray County is of the opinion and deems it to be in the best interest of the citizens of Murray County that a one percent Transportation Special Local Option Sales Tax be imposed within the County for a period of not greater than five years;

WHEREAS, prior to the call of the election of the referendum on the special local option sales tax, the County and the City of Chatsworth and the City of Eton are desirous to enter into an agreement as authorized by Article IX, Section III of the Georgia Constitution and pursuant to O.C.G.A. § 48-8-260 (5);

WHEREAS, said agreement by and between the County and City of Chatsworth and the City of Eton expressly contingent and subject to voter approval and passage of the transportation special local option sales tax at a duly called election;

WHEREAS, the County and the City of Chatsworth and the City of Eton desire to enter into an agreement for the benefit of all the citizens of Murray County, as well as for the benefit of the citizens of the City of Chatsworth and the City of Eton, will be served by the allowable purposes as contained in O.C.G.A. Section 48-8-121.

NOW THEREFORE, in consideration of the declaratons above, as well as the promises contained herein, the County and the City of Chatsworth and the City of Eton hereby mutually agree and covenant as follows:

1.

The County shall make available to the City of Chatsworth a sum equal to 8.0 percent of all net proceeds and the County shall make available to the City of Eton a sum equal to 2.0 percent of all net proceeds collected as a result of the one percent transportation special local option sales tax for a period equal to the imposition of the special local option sales tax within Murray County, Georgia.

2,

The County and the City of Chatsworth and the City of Eton recognize that the transportation special local option sales tax is a countywide tax and the City of Chatsworth and the City of Eton are not required by law to receive any portion of the net proceeds. In consideration of the receipt of 8.0 percent and 2.0 percent of the the net proceeds, respectively of the transportation special local option sales tax, the City hereby agrees to use any of the proceeds received to fund any and all of the allowable purposes as aforestated for the benefits of all the citizens of Murray County.

3.0

In further consideration of receipt of 8.0 percent and 2.0 percent of net procees of the transportation special local option sales tax, respectively the City of Chatsworth and the City of Eton hereby agree to allow all citizens of Murray County equal access and opportunities to the use and enjoyment of roads, bridges, sidewalks and other allowable purposes and uses owned and operated by the City of Chatsworth and the City of Eton as provided or extended to the citizens of the City of Chatsworth and City of Eton.

4.0

It is understood by the County and the City of Chatsworth and the City of Eton that all proceeds of the transportation special local option sales tax will be collected by the State of Georgia Department of Revenue, who shall pay out the proceeds collected. The County shall pay to the City of Chatsworth a sum equal to 8.0 percent of the net proceeds pro rata as received by the County from Georgia Department of Revenue and the County shall pay to the City of Eton a sum equal to 2.0 percent of the net proceeds pro rata as received by the County from Georgia Department of Revenue.

Notwithstanding the above, the County will assist the City of Chatsworth with receiving their monthly distribution directly from the Georgia Department of Revenue. The City of Eton shall receive two percent of the monthly proceeds; however their portion shall be held by Murray County and allocated to transportation projects as directed by the City of Eton. The County shall provide Eton with a monthly accounting of revenues and expenditures pertaining to their portion;

5.

It is understood and agreed by the City of Chatsworth and the City of Eton and the County that this agreement is the Complete agreement by the parties and integrates and incorporates all prior understandings and discussions concerning the transportation special local option sales tax, and the distributing of its proceeds, that this agreement cannot be modified except by writing executed and duly adopted by the parties as provided by law

IN WITNESS WHEREOF, the County and the City of Chatsworth and the City of Eton have caused this agreement to be duly enacted by the proper officers and so attest with their seals this 6th day of September, 2019.


